- 4. The policy of making no changes in revision of texts during the year has been carried out. Suggestions for revisions deemed necessary are filed and when a re-print is necessary, decision is then made as to the necessity for revision.
- 5. Training Regulations are used as basic texts where applicable. Texts prepared here supplement Training Regulations and are used only when no appropriate Training Regulations are available.
- 6. Tactical Functions of Larger Units was re-introduced into the course this year with beneficial results. By offering the student a larger view of military operations, he is enabled to more readily visualize the work of lesser units.
- 7. The tutorial method of instruction was continued with much better results than last year. Regular times and places for meeting of committees were prescribed. By the first of January it was found that this system of instruction was no longer necessary and it was then discontinued, except as asked for by a few students.
- 8. A system of marking students "S" (Satisfactory) and "U" (Unsatisfactory) with necessary comments on the problems to indicate important errors was continued, with highly beneficial results.
- 9. During the summer two officers were sent to summer school at the University of Michigan for the purpose of investigating the systems used there as to methods of instruction. These officers voluntarily gave up their time

and upon their return to the schools here their experience was utilized. The net result was a decided improvement in methods of instruction with a corresponding beneficial result to the students. Another officer is to take this same course at the University of Michigan this year.

- 10. I am convinced that more care should be taken in the selection of officers to become students at this school. Officers coming here should be, where practicable, graduates from the advanced course of some special service school, or with an equal instruction received by some other method. In this way time could be saved here by shortening the refresher and review course we now maintain at these schools at the beginning of the course.
- 11. I further believe that a board of General officers similar to the one which now passes upon the eligibility of graduates for the General Staff Eligible List should meet prior to the detail of officers as students and only such officers should be sent here as, from their record, would certainly be placed upon the General Staff Eligible List upon graduation. It is a waste of time and money to send officers here whose efficiency records show they are not suitable material for General Staff duty.
- 12. The physical condition of officers coming here should be carefully determined before they are detailed. Emphasis is placed here upon regular and systematic exercise on the part of the students during the course and, due to the facilities offered by the Post and to the splendid cooperation of the Army Y.M.C.A., a noticeable increase in the amount of physical exercise taken by officers was noted last year.
- 13. The decision of the War Department to do away with the rating of Honor and Distinguished graduates will be of assistance. I am firmly convinced that some of the time previously spent by students in trying out methods by which they will get a better mark will now be spent by these officers in absorbing more fully the principles which are taught.
- 14. In last year's report I recommended that the great percentage of instructors be taken from officers who have been graduated from this school for one or more years and

who are, preferably, Army War College graduates. In detailing officers this year the War Department was very liberal in complying with this request.

SPECIAL COMMAND AND GENERAL STAFF SCHOOL

15. With one exception the officers composing the Special Command and General Staff School were well qualified to carry on the work here. I recommend that this class be increased in size, provided funds are available.

THE COMMAND AND GENERAL STAFF CORRESPONDENCE SCHOOL

Director: LIEUTENANT COLONEL H. A. WELLS, Infantry. Chief: LIEUTENANT COLONEL J. SCOTT, Infantry.

- 16. The total number enrolled for the Correspondence Course is about eight hundred (800). Under the present scheme the exercises and problems are prepared here and sent out to various corps area commanders who are charged with the duty of enrolling and instructing and of distributing and marking problems. The Director of the Correspondence School recommends that the preparation, distribution, and marking of problems be centralized in this school. thereby reducing the total overhead. To do this would necessitate an appreciable addition to our instructor personnel of some twenty officers. In view of the fact that the Corps Area Commanders are responsible for the training of officers within their corps area I believe that the present system is the better, in that there is control as to type of exercises and problems, with a decentralization through corps area commanders of methods of instruction. should be now available in every corps area a sufficient number of officers who are thoroughly capable of marking these problems.
- 17. Each year the War Department calls upon The General Service Schools to prepare one or more Training Regulations. I believe this is an error. This institution is a school of instruction wherein doctrines are taught which are promulgated by the War Department. Therefore, Training Regulations, which promulgate War Department doctrines, should be prepared by the War Department. It seems to be a good scheme to send these Training Regulations to the schools for review but the main work of preparing should, in my opinion, be handled by the War Department.
- 18. Translation: During the year there has been a marked increase in German translations.
- 19. I again desire to express my grateful acknowledgment for the splendid backing received by the schools from the War Department.

It is also my pleasure to acknowledge the efficient, loyal, capable and conscientious support given me by the Assistant Commandant, Directors and Faculty, as well as from the members of the permanent garrison and student body.
