Chief Warrant Officer Five Aaron Anderson enlisted in the United States Army in 1995 as a 96B, All Source Intelligence Analyst. He was commissioned as a Second Lieutenant in the Air Defense Branch in April 2000 after completing Officer Candidate School at Fort Benning, Georgia, later serving as an Air Defense Officer and Military Intelligence Officer. In 2006, Captain Anderson was appointed to the rank of Warrant Officer One as an All-Source Intelligence Technician. He holds an associate degree in Social Science from Jamestown Community College, Jamestown, New York, a bachelor's degree in Criminal Justice from the State University of New York at Brockport, Brockport, New York, and a master's degree in Strategic Intelligence from the National Intelligence University, Washington, D.C. Chief Warrant Officer Five Anderson is a graduate of the Warrant Officer Senior Service Education Course.
