1. THIS MESSAGE SUPERSEDES REFERENCE B AND ANNOUNCES STANDARDIZED
INSTRUCTIONS FOR SOLDIERS ATTENDING INITIAL MILITARY TRAINING (IMT) AND
AVIATION BRANCH REQUIREMENTS AT FORT RUCKER, AL.

2. GENERAL ASSIGNMENT RULES:

2.A. ALL ACTIVE AND RESERVE COMPONENT COMMISSIONED ARMY OFFICERS BRANCHED
AVIATION WILL ATTEND THEIR IMT (E.G., BOLC-B) AND REQUIRED FLIGHT TRAINING
(E.G., HOST, SERE, IEWR AND APPLICABLE ADVANCED AIRCRAFT TRACK) IN A
PERMANENT CHANGE OF STATION (PCS) TRAVEL STATUS. PER REFERENCE A, TRAINING
AT THE SAME LOCATION, 20 WEEKS OR MORE IS A PCS. PERMANENT CHANGE OF
STATION TRAVEL ORDERS WILL REFLECT A REPORT DATE OF TEN DAYS PRIOR TO CLASS
START TO SUPPORT REQUIRED IN-PROCESSING REQUIREMENTS. THE UNITED STATES
ARMY MILITARY ACADEMY AVIATION BRANCH OFFICER'S ORDERS WILL REFLECT A
REPORT DATE OF TEN DAYS PRIOR TO CLASS START OR WITHIN 60 DAYS OF THEIR
ENTRY DATE ON ACTIVE FEDERAL SERVICE, WHICHEVER IS EARLIER.

2.B. ALL ACTIVE AND RESERVE COMPONENT SOLDIERS ATTENDING THE WARRANT
OFFICER CANDIDATE SCHOOL (WOCS) AND SELECTED FOR AVIATION WILL ATTEND WOCS
IN A TEMPORARY DUTY OR ACTIVE DUTY TRAINING STATUS. ALL SUBSEQUENT IMT
REQUIREMENTS WILL BE EXECUTED IN A PERMANENT CHANGE OF (PCS) STATUS AND
INCLUDES WARRANT OFFICERS TRANSFERRING TO AVIATION. THIS INCLUDES 153A,
ROTARY WING AVIATOR TRAINING, WARRANT OFFICER BASIC COURSE AND FLIGHT
TRAINING. PERMANENT CHANGE OF STATION ORDERS WILL REFLECT A REPORT DATE
OF
10 CALENDAR DAYS PRIOR TO CLASS START DATE OF INITIAL AVIATION FLIGHT
SCHOOL ENTRY COURSE, AVIATION WARRANT OFFICER BASIC (2C-IERW (CC)(WO)) OR

IF WOBC IS BYPASSED TO DUNKER (2C-F99/600-F16(CT), TO MEET REQUIRED IN-PROCESSING REQUIREMENTS. THIS MESSAGE DOES NOT APPLY TO SOLDIERS WHO ARE SLATED TO BECOME NON-FLYING AVIATION WARRANT OFFICERS IN 150A, 150U AND 151A.

2.C. WARRANT OFFICER FLIGHT TRAINING ENLISTEES SELECTED FOR 153A ROTARY WING AVIATOR WILL ATTEND BASIC COMBAT TRAINING AND/OR WOCS IN AN INITIAL ENTRY TRAINING (IET) OR INITIAL ACTIVE DUTY FOR TRAINING (IADT) STATUS. PERMANENT CHANGE OF STATION ORDERS TO ATTEND WOBC AND FOLLOW-ON FLIGHT TRAINING WILL REFLECT A REPORT DATE OF 10 CALENDAR DAYS PRIOR TO WOBC START DATE TO MEET REQUIRED IN-PROCESSING REQUIREMENTS.
