These synopses provide readers with the new doctrinal concepts.

Army Doctrine Reference Publication


Army Publishing Directorate (APD) published the following ADRP during the second quarter of FY15: ADRP 1-02. A brief synopsis of the publication and a link to its location are provided below.

ADRP 1-02, *Terms and Military Symbols*, constitutes approved Army doctrinal terminology and symbology for general use. It builds on the foundational doctrine established in ADP 1-02.

The principal audience for ADRP 1-02 is all members of the Profession of Arms. Commanders and staffs of Army headquarters serving as joint task force or multinational headquarters should also refer to applicable joint or multinational doctrine concerning the range of military operations and joint or multinational forces. Trainers and educators throughout the Army will also use this publication.

Field Manual Publication


APD published the following field manual during the second quarter of FY15: FM 3-99. A brief synopsis of the publication and a link to its location are provided below.

FM 3-99, *Airborne and Air Assault Operations*, establishes doctrine to govern the activities and performance of Army forces in forcible entry (specifically airborne and air assault operations) and provides the doctrinal basis for vertical envelopment and follow-on operations. This publication provides leaders with descriptive guidance on how Army forces conduct vertical envelopment within the simultaneous combination of offense, defense, and stability. These doctrinal principles are intended to be used as a guide and are not to be considered prescriptive.

FM 3-99 encompasses tactics for Army airborne and air assault operations and describes how commanders plan, prepare, and execute airborne and air assault operations by means of joint combined arms operations.

Army Techniques Publications


APD published the following Army techniques publications during the second quarter of FY15: ATP 1-06.3, ATP 2-19.4, ATP 3-01.18, ATP 3-34.22, ATP 3-34.40, ATP 3-36, ATP 3-39.10, ATP 3-39.34, ATP 4-46. A brief synopsis of each publication and a link to its location are provided below.

ATP 1-06.3, *Banking Operations*, was published in January of 2015. ATP 1-06.3 provides financial management Soldiers and civilians with techniques for executing banking operations and the global connectedness of E-commerce systems at strategic, operational, and tactical levels.

ATP 1-06.3 provides doctrinal guidance to commanders and financial managers on how to leverage existing programs and technology, and identify and implement new technologies. The goal is to reduce cash on the battlefield, improve the Financial Management Support Center (FMSC) banking operations, improve the Financial Management Support Unit disbursing mission, and strengthen the economy across the theater of operations to create and support an effective exit strategy. ATP 1-06.3 describes various initiatives and proposed methods to strengthen the host-nation banking system, and fortify the host-nation economies throughout the theater of operations. The banking team supports the FMSC in forging a strong partnership among the host nation, the United States Army, the United States Treasury, the Department of State, and the Federal Reserve Bank network. This effort promotes the identification and elimination of capability gaps in the United States Army’s support of the Department of State’s economic goals within the theater pertaining to banking and E-commerce.

The principal audience for ATP 1-06.3 is all members of the Profession of Arms. Commanders and staffs of the Army headquarters serving as joint task force or multinational headquarters should also refer to applicable joint or multinational doctrine concerning the range of military operations and joint or multinational forces. Trainers and educators throughout the Army will also use this publication.




ATP 2-19.4, *Brigade Combat Team Techniques*, provides techniques for intelligence support to brigade combat team (BCT) operations. The techniques in this publication apply across the range of military operations and to all echelons of the infantry, armored, and Stryker BCTs.

The principal audience for ATP 2-19.4 is commanders, staffs, and Soldiers who are responsible for planning, preparing, executing, and assessing tasks of BCT intelligence cells. ATP 2-19.4 serves as a reference for personnel developing doctrine materiel and force structure, institutional and unit training, and standard operating procedures for BCT intelligence cells, subordinate battalion intelligence cells, the organic military intelligence company, and company intelligence support teams when formed.

This publication supersedes FM 2-19.4 (25 November 2008), TC 2-19.63 (9 November 2010), and TC 2-50.5 (6 January 2010).



ATP 3-01.18, *Stinger Techniques*, provides guidance for Stinger employment techniques supporting air defense operations. Its focus is to build a proficient Stinger team enabling them to accomplish their assigned missions. The effectiveness of Stinger varies directly with the individual skills of each team member and their collective proficiency. This publication provides nonprescriptive ways or methods used by the Stinger team to engage and destroy hostile air threats.

The principal audience for ATP 3-01.18 is commanders, staffs, supervisors, planners, and Soldiers.




ATP 3-34.22, *Engineer Operations—Brigade Combat Team and Below*, provides a doctrinal foundation for the conduct of engineer operations in support of unified land operations that focus on tactical maneuvers at the brigade combat team (BCT) level and below. The engineer support doctrine for the BCT focuses on tactical-level maneuvers. The engineer organizations that are organic to the BCT are optimized to perform combat engineering tasks (primarily mobility with limited capabilities in countermobility and survivability). Geospatial engineering support is provided by organic terrain teams. Additional engineering support (combat and general) comes from engineer organizations that are task-organized to the BCT or that provide support from echelons above brigade organizations. This publication is aligned with current BCT doctrine and describes engineer support for the armored BCT, infantry BCT, and Stryker BCT. (See FM 3-90.6.) Although the armored cavalry regiment and engineer company are not specifically addressed, the basic principles of this publication also apply to those organizations.

The principal audience for this publication is commanders and staffs at the BCT level and below. It is a primary manual for instructional purposes within the United States Army Engineer School and assists other Army branch schools in teaching the integration of engineer capabilities into Army operations.




ATP 3-34.40, *General Engineering*, provides general engineering doctrine for the Army and Marine Corps. This publication is linked to joint and Army doctrine to ensure its usefulness for joint and Army commanders and staffs. To comprehend this publication, readers must first understand the nature of unified land operations as described in ADP 3-0 and ADRP 3-0, joint engineer functions discussed in JP 3-34 and NWP 4-04, and Army engineer disciplines discussed in FM 3-34.

In addition, readers must also fully understand the discussion of engineer operations at echelons above brigade in ATTP 3-34.23, the fundamentals of assured mobility found in ATTP 3-90.4/MCWP 3-17.5 and ATP 3-90.8/MCWP 3-17.5, the discussion of Seabee operations in the Marine air-ground task force (MAGTF) found in NTTP 4-04.1M/MCWP 4-11.5, the discussion of base camps found in ATP 3-37.10/MCRP 3-17.7N, and the protection tasks discussed in ADP 3-37 and ADRP 3-37.

The principal audience for this publication is all members of the military Profession of Arms. Commanders and staffs of Army and Marine headquarters serving as joint task force or multinational headquarters should also refer to applicable joint or multinational doctrine concerning the range of military operations and joint or multinational forces. This publication will be used in training and by educators throughout the Army and Marine Corps. The other intended audiences for this publication are the leaders and staff sections within engineer units that are required to conduct general engineering tasks.



ATP 3-36, *Electronic Warfare Techniques*, provides techniques for the application of electronic warfare in unified land operations. ATP 3-36 expands the discussion of the role of electronic warfare in cyber electromagnetic activities started in FM 3-38.

The principal audience for ATP 3-36 is all members of the Profession of Arms. Commanders and staffs of Army headquarters serving as joint task force or multinational headquarters should also refer to applicable joint or multinational doctrine concerning the range of military operations and joint or multinational forces. Trainers and educators throughout the Army will also use this publication.




ATP 3-39.10, *Police Operations*, provides guidance for commanders and staffs on police operations. Police operations support decisive action tasks (offensive, defensive, and stability or defense support of civil authorities). This publication emphasizes policing capabilities necessary to establish order and subsequent law enforcement activities that enable successful establishment, maintenance, or restoration of the rule of law. This publication describes police operations executed across the range of military operations and operational environments, with specific emphasis on police station operations and associated law enforcement patrol activities.

The principal audience for this publication is Army leaders and Army professionals at all echelons who are tasked with planning, directing, and executing police operations.




ATP 3-39.34, *Military Working Dogs*, serves as the foundation for military working dog (MWD) operations for the Army. The publication gives commanders and staffs an understanding of MWD capabilities and their integration into decisive action.

The principal audience for this publication is Army leaders and Army professionals at all echelons who are tasked with planning, directing, and executing MWD operations. ATP 3-39.34 is not a stand-alone reference and is intended for use in conjunction with Army regulations, Department of Defense directives, and other Department of the Army MWD-related publications.




ATP 4-46, *Contingency Fatality Operations*, was published on 17 December 2014 and superseded FM 4-20.64, *Mortuary Affairs Operations*. ATP 4-46 serves as a planning and operations guide for all personnel involved in mortuary affairs within a theater of operations. Additionally, the publication discusses the new Quartermaster Mortuary Affairs Company. Its mission is to provide the full range of mortuary affairs operations during contingency operations. It can perform any one of the following tasks: mortuary affairs collection point operations, mortuary affairs contaminated remains mitigation Site operations, theater mortuary evacuation point, or personal effects depot. This new unit is a combination of the quartermaster mortuary affairs company (echelons above corps) and the quartermaster collection company (mortuary affairs). The combination allows all mortuary affairs units to provide the same support to all areas of operations. ATP 4-46 introduces the terms and acronyms: Mobile Integrated Remains Collection System (MIRCS); mortuary affairs contaminated remains mitigation site (MACRMS); and Mortuary Affairs Reporting and Tracking System (MARTS).

ATP 4-46 provides a ready reference for units and Soldiers. It focuses on techniques used by Soldiers, small unit leaders, civilians, contractors, or host-nation personnel physically responsible for handling, transporting, receiving, or storing human remains or personal effects. This publication addresses the new force design of the mortuary affairs units and emphasizes safety and the MARTS. Users should not view this manual as a sole source of information.

The principal audience for ATP 4-46 is commanders, staffs, Soldiers at all levels, leaders, instructors, at military institutions, students, and doctrine and training developers. Commanders and staffs of Army headquarters serving as joint task force or multinational headquarters should also refer to applicable joint or multinational doctrine concerning the range of military operations and joint or multinational forces. Trainers and educators throughout the Army will also use this publication.

Multi-Service Publications


APD has published the following multi-Service Army techniques publications during the second quarter of FY15: ATP 3-04.64, ATP 3-22.40, and ATP 3-34.84. A brief synopsis of each publication and a link to its location are provided below.

ATP 3-04.64, *Multi-Service Tactics, Techniques, and Procedures for the Tactical Employment of Unmanned Aircraft Systems*, provides commanders, operational staffs, requestors, and unmanned aircraft operators with descriptive procedures for effective planning, tasking, integration, and utilization of unmanned aircraft systems (UASs).

It supports planners and warfighters by establishing tactics, techniques, and procedures for tactical planning, requesting UASs, and using UAS capabilities. It addresses tactical and operational considerations regarding mission planning, command and control of operations, system capabilities, and limitations.

It applies to all commanders and their staffs that participate in operations involving UASs. This publication is unclassified with restricted Distribution Statement C, in accordance with Department of Defense Directive 5230.24, *Distribution Statements on Technical Documents*.



ATP 3-22.40, *Multi-Service Tactics, Techniques, and Procedures for the Employment of Nonlethal Weapons*, discusses the policy and parameters governing nonlethal weapons. This publication increases commander and subordinate awareness for nonlethal weapons planning, capabilities, and employment. It provides employment considerations, but is neither prescriptive nor restrictive regarding commander authority to organize forces and execute missions deemed appropriate. It provides an overview of nonlethal weapons and discusses fundamental employment considerations and training requirements for the effective integration of nonlethal weapons into operations.

This publication applies to leaders planning to employ nonlethal weapons.



It describes United States military dive mission areas, force structure, equipment, and primary missions each Service can provide in support of joint operations to assist commanders and staffs at all levels.


